Plaintiff's claim against the Defendant is for:

- a) *A declaration that the words and statements inter alia made, uttered, and published by the Defendant on his Facebook Timeline and contained in the particulars of defamation as attached and especially in paragraphs 20, 22, and 23 of the Statement of Claim herein are defamatory of his character.*
- b) *An order of the Court directed at the Defendant to publish on three consecutive occasions, on the same platform that he published the defamatory words i.e. Facebook Timeline and in the Daily Graphic, an unqualified retraction and an apology, with the same prominence as given to the issuance of the defamatory words.*
- c) *An order of the court compelling the Defendant to immediately cause to be deleted all the defamatory statements he made about the person and character of the Plaintiff either directly or indirectly on his Facebook timeline.*
- d) *General Damages of the sum of Three Million Ghana Cedis for defamation.*
- e) *Exemplary Damages of Two Million Ghana Cedis for malicious conduct of the Defendant in defaming the Plaintiff.*
- f) *Costs including legal fees, and*
- g) *Any other relief(s) that the Honourable Court may deem fit.*

**STATEMENT OF CLAIM**

---

1. The Plaintiff is the current Chief Executive Officer of the Komfo Anokye Teaching Hospital in Kumasi having being appointed and being in office since December 2022.
2. The Defendant is a Lawyer practising from Holy Trinity Chambers in Kumasi and the former external Lawyer of Komfo Anokye Teaching Hospital where he acted from 2018 to December 2023.
3. Plaintiff says that he worked with the Defendant for almost a year and he tried to be as cordial and professional as he could for the sake of the work until the Defendant reverted to taking steps that was unethical and making defamatory statements about the Hospital and his person.
4. Plaintiff says that he had been a lecturer at the Kwame Nkrumah University of Science and Technology for 16 years prior to his appointment as Chief Executive Officer of the Komfo Anokye Teaching Hospital.

5. Plaintiff says that his diligence and sheer determination in life led him to being awarded as an Associate Professor of Haematology at the Faculty of Allied, Health Sciences at the Kwame Nkrumah University of Science and Technology.
6. Plaintiff says that he has been the Head of Department for 5 years, Dean of the Faculty and the Vice Dean of Students, and also the Deputy Director of Students Affairs at the Kwame Nkrumah University of Science and Technology.
7. Plaintiff says that he has been the National Vice President of the University Teachers Association of Ghana and the President of the same association at the Kwame Nkrumah University of Science and Technology.
8. Plaintiff says that he has been a member of the governing council of the Kwame Nkrumah University and also a member of the governing council of the Nursing and Midwifery Council of Ghana.
9. Plaintiff says in addition to all these, he has chaired very important committees across the educational circles and as an astute researcher, he has widely published in very reputable journals making him very much known.
10. Plaintiff says that in December 2022 when he commenced his work as Chief Executive Officer of the Komfo Anokye Teaching Hospital the Defendant was the Lawyer representing the hospital and the Defendant had worked very closely with the Board and former CEO.
11. The Defendant acted as the Lawyer for Komfo Teaching Hospital and while serving as the lawyer for the hospital he owed a fiduciary duty towards the hospital and a duty of confidentiality towards the Hospital.

12. The Plaintiff avers that on or about the 18<sup>th</sup> day of December 2023, the Hospital attention was drawn to the Defendant's Facebook Timelines some comments made by the Defendant on its patient and some other comments that seeks to denigrate the image of the Hospital.
13. Plaintiff says that such conduct of the Defendant was reckless and was new as throughout the tenure of Defendant's friend who happened to be the former CEO of the Komfo Anokye Teaching Hospital, the Defendant never behaved in such discourteous manner.
14. The Plaintiff avers that the Hospital wrote a letter to confirm that he was the author of the Facebook postings and same was replied to by the Defendant in a disrespectful word apart from confirming that he is the author of those posts and continued making posts denigrating the Hospital.
15. The Plaintiff avers that the Defendant commenced these image tarnishing of the Hospital after **His Royal Majesty, King of Asante Otumfuo Osei Tutu II** had launched the "**Heal Komfo Anokye Project**" seeking to solicit funds to renovate the Hospital Infrastructure.
16. Plaintiff says that with the kind gesture of the Asante King, people have been encouraged to donate to renovate the hospital and make same fit for purpose and yet the Defendant, as former Lawyer for Komfo Anokye Teaching Hospital who ought to know better continues to pass some very distasteful comments on his Facebook wall discouraging people from donating.
17. The Plaintiff avers that due to this breach of confidentiality on the part of the Defendant in releasing information on the relationship between Komfo Anokye Hospital, its patients, and general operations of the hospital, the Hospital deemed it as unethical conduct on the part of former lawyer and consequently filed a complaint at the **General Legal Council**.



18. The Plaintiff avers that as a result of the unethical conduct of the Defendant and coupled with a clear demonstration that he was unwilling to work with the new management, the Hospital was not in a position to renew his contract.
19. Plaintiff avers that the Defendant since his contract was not renewed has now commenced a full-scale attack on the Plaintiff's reputation and these statements are false and being made at a time that the Hospital through the leadership of the Komfo Anokye Teaching Hospital and with the ultimate ownership by His Royal Majesty is soliciting for funds.
20. The Plaintiff says that the Defendant while acting as the Lawyer for Komfo Anokye Teaching Hospital, started making the following comments against the Plaintiff by way of Innuendos in the month of December 2023:

15<sup>th</sup> December 2023

*Stealing galore. How can you award 4 contracts to one person on One day without knowing that the person is an employee.*

20<sup>th</sup> December 2023

*Stealing galore, I will be serializing the rot on my page with real evidence. They are living a life of lie.*

21. The Plaintiff avers that when a journalist reminded him of he being a lawyer of the hospital and cannot be seen denigrating the hospital he responded accusing the journalist and continued with his defamatory statements seeking to represent them as facts.
22. The Plaintiff avers that the Defendant continued with his defamatory statements by way of Innuendo's by attacking the Plaintiff who is the leader of the Project by stating the following on his timeline and on these dates:

12<sup>th</sup> January 2024

Who are those behind Heal Komfo Anokye? Can you vouch for their integrity?

18<sup>th</sup> January 2024

May we say God save the King. Bcos no one will save his project to heal Komfo Anokye from the hyenas.

23. The Plaintiff says that the Defendant after passing these Innuendos' now proceeded to make the following defamatory statements against the Plaintiff on the following dates:

24<sup>th</sup> January 2024

On 4<sup>th</sup> July 2023, the Chief Executive Officer of Komfo Anokye signed a cheque no: 220588 for GHC 100,000 which was drawn in the name of deputy director of budget, to date he has not been able to account for money. Mr Kojo Marfo are you aware if this

- 24<sup>th</sup> January 2024

Again, on 4 July 2023, the Chief Executive Officer of Komfo Anokye signed a cheque with no: 220589 for GHC 80,000.00, drawn in the name of deputy director of budget. To date he has not been able to account for the money. Mr. Kojo Marfo, how much did you get? The rot under this guy stinks!

- 26<sup>th</sup> January 2024

On 14 August 2023, again the Chief Executive Officer of Komfo Anokye signed another cheque with no: 220953 in the sum of GHC 120,000.00, drawn in the name of deputy director of budget. To date he has not been able to account for the money. You see why he pays money to the media?

The rot in Komfo Anokye under this guy is mind blowing! It is very sad though that he can portray to be doing good when in fact he is stealing from us. God heal Komfo Anokye.



- 30<sup>th</sup> January 2024

*Komfo Anokye is rotten. It is disgusting*

- *Now that Ghana is sadly out and coming home, we will resume talking about the stealing going on at Komfo Anokye. The guy is a thief!*

24. The Plaintiff avers that the Hospital was compelled to file a suit on the 31<sup>st</sup> day of January 2024 against the Defendant, its former lawyer, when it continued such disparaging remarks and this action is titled SUIT No. GJ12/149/24 KOMFO ANOKYE TEACHING HOSPITAL v. KWAME ADOFO.

25. The Plaintiff avers after being served with the suit mentioned above, the Defendant has continued with his defamatory statements against the Plaintiff and Hospital and same can be seen from the following posts made on his timeline from December to date:

DECEMBER 2023

*Mr. Kwame Adofo on the 15<sup>th</sup> of December, 2023 made the statement below*

*“Stealing galore. How can you award 4 contracts to one person on One day without knowing that the person is an employee”?*

*Mr. Kwame Adofo on the 20<sup>th</sup> of December, 2023 made the statement below*

*“Stealing galore, I will be serializing the rot on my page with real evidence. They are living a life of a lie.”*

*Mr. Kwame Adofo on the 27<sup>th</sup> of December, 2023 made the statement below*

*“People do you know why Mr Kojo Marfo is always attacking the Board Chairman of Komfo Anokye on his show? It is because only the*

*Board chairman and a few people are resisting the rotting of the system.*

*JANUARY 2024*

*Mr. Kwame Adofo on the 12<sup>th</sup> of January, 2024 made the statements below*

*“Who are those behind Heal Komfo Anokye? Can you vouch for their integrity?”*

*“May we say God save the King. Bcos no one will save his project to heal Komfo Anokye from the hyenas.”*

*Mr. Kwame Adofo on the 13<sup>th</sup> of January, 2024 made the statements below*

*“How can we be sure that those behind “Heal Komfo Anokye” will not milk the cow like that National cathedral project”*

*“They say, the correct question should be, apart from the King can you vouch for the integrity of the people behind the Heal Komfo Anokye project?”*

*Mr. Kwame Adofo on the 18<sup>th</sup> of January, 2024 made the statement below*

*“What I have seen recently makes me cringe. It makes me wonder who will save the King’s project from the hyenas”*

*Mr. Kwame Adofo on the 24<sup>th</sup> of January, 2024 made the statement below*

*“On 4 July 2023, the Chief Executive officer of Komfo Anokye signed a cheque with no: 220588 for GHC 100,000 which was drawn in the name of deputy director of budget, to date he has not been able to account for the money. Mr Kojo Marfo are you aware of this?”*

*"Again, on 4 July, 2023, the Chief Executive officer of Komfo Anokye signed a cheque with no: 220589 for GHC 800,000, drawn in the name of deputy director of budget. To date he has not been able to account for the money. Mr Kojo Marfo, how much did you get? The rot under this guy stinks!"*

*Mr. Kwame Adofo on the 26<sup>th</sup> of January, 2024 made the statements below:*

*"You know why Mr Kojo Marfo is always attacking the Board Chairman of Komfo Anokye? Is because he wants to help his protégé to get his way in milking Komfo Anokye"*

*"The rot in Komfo Anokye under this guy is mind blowing! It is very sad though that he can portray to be doing good when he is in fact stealing from us. God Heal Komfo Anokye!"*

*"On 14 August 2023, again the Chief Executive officer of Komfo Anokye signed another cheque with no: 220953 in the sum of GHC 120,000 drawn in the name of deputy director of budget. To date he has not been able to account for the money. You see why he pays money to the media?"*

*Mr. Kwame Adofo on the 30<sup>th</sup> of January, 2024 made the statement below:*

*"Komfo Anokye is rotten. It is disgusting"*

*Mr. Kwame Adofo on the 31<sup>st</sup> of January 2024 made the statements below*

*"Mr Kojo Marfo, are you aware that the Chief executive officer of Komfo Anokye, has been giving contracts to an employee trading under the name of Prinky star enterprise in breach of the procurement law? The guy will go to jail.*



*"Mr Kojo Marfo do you know a trading name Prinky Star enterprise? Ha ha. It is one of the vehicles being used by your friend to steal from Komfo Anokye. Shameful"*

#### FEBRUARY, 2024

*Mr. Kwame Adofo on the 1<sup>st</sup> of February, 2024 made the statement below:*

*"Mr Kojo Marfo, the dossier I have on your friend stealing from Komfo Anokye, he himself cannot deny it. So, you keep putting your credibility on the line in vouching for a thief, your own credibility will be affected wai. Good morning."*

*Mr. Kwame Adofo on the 2<sup>nd</sup> of February, 2024 made the statement below*

*"On 5 Sept 2023, the Chief Executive officer of Komfo Anokye, gave a contract to an employee trading under the name of Prinky Star enterprise in breach of the procurement law. The amount was Ghc 10,140. Mr Kojo Marfo, do you know about this? Your friend is flouting All the laws"*

*Mr. Kwame Adofo on the 8<sup>th</sup> of February, 2024 made the statement below:*

*"Coward, you are afraid of more revelations. Stay tuned"*

#### MAY, 2024

*Mr. Kwame Adofo on the 1<sup>st</sup> of May, 2024 made the statement below:*

*"if the people know that he has stolen at least GHC 300,000 from Komfo Anokye, would they still support him?"*

*Mr. Kwame Adofo on the 17<sup>th</sup> of May, 2024 made the statement below:*

*"Public and civil servants are even more corrupt. Miracles, why hasn't the President responded to my petition against the CEO".*

18. Mr. Kwame Adofo on the 24<sup>th</sup> of May, 2024 made the statement below:

*“The guy has stolen GHC 300,000 and the unions are saying they stand in solidarity with him? Mo agyimi papa”*

26. Plaintiff says that the Defendant has sought to making these slide comments against the person of the Plaintiff and creating innuendos geared towards prejudicing the minds of reasonable people that the Plaintiff is superintending some corruption and thievery at Komfo Anokye Hospital.

27. The Plaintiff repeats paragraphs 20, 22 and 24 herein and avers that by way of innuendo, the false and malicious utterances made by the Defendant meant and right-thinking members of the society naturally and ordinarily understood the statements to mean that the Plaintiff:

- a. **is a thief, fraudster, cheat, squeeze, full of deception, dishonest and corrupt, which said acts are criminal under the laws of Ghana.**
- b. **is a careless, callous, cold-hearted, uncaring and insensitive and using the Heal the Komfo Anokye Project funds for his personal benefit.**
- c. **unduly influenced the Procurement officers in the Hospital and doing without recourse to the law.**
- d. **is involved in conflict of interest and using the companies of cronies to syphon hospital funds.**
- e. **Is dishonest and morally corrupt and cannot be made to lead the Komfo Anokye Hospital and the Heal the Komfo Anokye Project.**

28. Plaintiff says that Defendant's spirited and audacious manner in the publications complained are authored with malice and with the sole intent of reducing Plaintiff in the estimation of all right-thinking members of society as a corrupt, greedy, a thief and an uncaring leader.

### Particulars of Exemplary Damages

29. The Plaintiff relies on the facts and matters as set out *in extenso* above in support of the claim for damages, including aggravated damages, for malicious defamation that:

- a. The defamatory statements uttered by the Defendants was uttered, broadcast or published by Defendant's recklessly and not caring to verify the truth or accuracy thereof;
- b. The defamatory statements were uttered, broadcast or publicized without caution maliciously with intent to cause damage and injury to Plaintiff's hard-earned reputation, to reduce him into ridicule and to reduce his image in the estimation of right-thinking members of the society;
- c. The Defendant knew that once the aforesaid defamatory statements were made, since he was the former lawyer of the Hospital same could be regarded by people as true when he knew same was false.
- d. The Defendant not having his contract renewed seeks to use or refer to incident or information that he purportedly came to as a result of his service to the Hospital and use same disingenuously by presenting them as facts when they were not to defame the Plaintiff.
- e. The Defendant has used these defamatory statements to use it as a bases to file a petition against the Plaintiff and which has caused same to be published by media houses thereby getting the Plaintiff and the Hospital to court public opprobrium.

30. Plaintiff says that the aforesaid defamatory statements were disseminated to many persons through Defendant's Facebook timeline.

31. Plaintiff says that such reckless comments some of which directly mentions Plaintiff as Chief Executive of Komfo Anokye are complete falsehoods but posted to create disaffection for the Plaintiff in the eyes of right-thinking members of society.



32. Plaintiff says that the Facebook posts by the Defendant on his Facebook wall has created a great dent on the Plaintiff's hard-earned reputation and he has even had to be called before the King of Asante on this issue.
33. Plaintiff says that even his former students have had to call him to express their disappointments should it be that the statements as posted by the Defendant is true.
34. Plaintiff says that the false and reckless statements made by the Defendant continues to lower his esteem in the face of right-thinking Ghanaians and his respect and integrity in the academia have been grossly affected.
35. Wherefore the Plaintiff's claim against the Defendant is for:
- a) *A declaration that the words and statements inter alia made, uttered, and published by the Defendant on his Facebook Timeline and contained in the particulars of defamation as attached and especially in paragraphs 20, 22, 23 and 25 of the Statement of Claim herein are defamatory of his character.*
  - b) *An order of the Court directed at the Defendant to publish on three consecutive occasions, on the same platform that they published the defamatory words i.e. Facebook Timeline and in the Daily Graphic, an unqualified retraction and an apology, with the same prominence as given to the issuance of the defamatory words.*
  - c) *An order of the court compelling the Defendant to immediately cause to be deleted all the defamatory statements he made about the person and character of the Plaintiff either directly or indirectly on his Facebook timeline.*
  - d) *General Damages of the sum of Three Million Ghana Cedis for defamation.*
